Detention Services

The purpose of Detention is to safely and securely detain children who are charged with delinquent offenses or violations of Court orders. Detention provides structure, safety, remediation, rehabilitation and educational services for children between the ages of 8 and 17.

We fulfill this responsibility by first believing all children are capable of success.

Our children participate in a variety of programs including:

- School
- Dog therapy
- Spiritual services
- Library services
- Motivational speakers
- Drug abuse & prevention services
- Yoga
- Culinary
- Gardening
- Physical activity



Our Positive Behavioral Intervention Support and Step Up programs build on your child's strengths and helps them better meet their life challenges.

Staff

Our children are our future. We are committed to treating all of our children fairly. Everyone's safety is treated as equally important.

Our Detention Team members are professional, dedicated and caring. They always put your children's best interests first. Detention officers are trained in youth development, effective communication methods, affects of trauma, substance abuse, and how to help children who are in crisis. Our detention officers serve as "mentors" to our children and will help them throughout their stay by being open to discussions about their needs, personal goals etc.

Our goal is to help your child learn skills that lead them to better decision making. Our children are also provided medical and mental health assessments and services while they are here.

We believe that with structure, quality programs, education and supportive role models all children are capable of greatness.

Facilities

The Juvenile Detention Center is an 162-bed facility that is divided into eleven living units. Each living unit contains a dayroom, classroom, shower stalls, individual bedrooms and an outdoor recreation area.



Daily Weekday Schedule

To build skills, provide consistency and stability in the children's lives, we provide them with a daily structured schedule. The following weekday schedule is as follows:

- ◆ 6:15 a.m. — Wake up & showers
- ◆ 8:30 a.m.—4:00 p.m. — School
- ◆ 4:00 p.m.—6:00 p.m. — Programming
- ◆ 6 p.m. — 8 p.m. — Leisure time

Children receive 1 hour of physical activities daily, three meals and three snacks a day.

We offer visitation sessions seven days a week. All visitors other than parents and guardians must have permission from your child's probation officer to visit.

You may request the visitation schedule from your child's probation officer, at the reception desk, from detention or contact 724-9837 for the schedule.

Children may write and receive letters. Children may also call their parents/guardians on a weekly basis.

Attorneys may visit their child clients any day of the week except during school hours.
